(THIS IS A VERBAL STATEMENT THAT JEFFREY HAVARD STATED TO ME ON THE MORNIG OF 02-22-02)

WHILE TALKING TO JEFFREY HAVARD ABOUT THE DEATH OF CHLOE BRITT HE STATED THAT HE HAD MET THE MOTHER OF CHLOE, REBECCA BRITT SEVERAL MONTHS BACK AND SHE HAD MOVED HERSELF AND CHLOE IN WITH HIM WHEN HE GOT HIS TRAILER AT 33 MONTGOMERY RD. ABOUT 3 TO 4 WEEKS AGO. HE STATED THAT THE DAY OF THE INCIDENT HE HAD SLEPT MOST OF THE DAY AND WHEN HE WOKE UP CHLOE WAS CRYING SO REBECCA DECIDED TO TAKE IT FOR A RIDE TO QUIETEN HER DOWN LIKE SHE NORMALLY DID BUT JEFFREY STATED THAT HE DID NOT WANT TO GO SO HE STAYED AT HOME TO START CLEANING UP AND AFTER REBECCA ARRIVED BACK HOME FROM RIDING WITH CHLOE SHE PUT HER IN THE SWING AND LASKED HER TO GO TO THE STORE AND PICK UP A FEW GROCERIES AND GAVE HER \$40.00 TO GET THEM WITH. SHE WENT TO THE STORE BUT LEFT CHLOE WITH ME. WHILE REBECCA WAS GONE JEFFREY STATED THAT CHLOE WOKE UP AND WAS FUSSY SO HE TOOK HER INTO HIS BED ROOM AND TOOK HER DIAPER OFF BECAUSE HE THOUGHT IT WAS DIRTY BUT IT WAS NOT BUT AT THIS TIME CHLOE SPIT UP ON HERSELF AND HIS BED SO HE DECIDED TO GIVE HER A BATH WHICH HE DID AND THEN WENT AND PUT HER TO BED AND RUBBED BABY LOTION WITH LAVENDER IN IT ON CHLOE FROM HEAD TO TOE. ON ABOVE DATE AT OR ABOUT 10:34 PM MYSELF DEPUTY BUDDY FRANK (A-13) AND DEPUTY RAY BROWN (A-20) WERE DISPATCHED TO NTZ. COMMUNITY HOSPITAL TO CONTACT OFFICER JOHNNY BALDWIN OF THE NTZ. P.D. UPON OUR ARRIVAL OFFICER BALDWIN STATED THAT REBECCA BRITT HAD BROUGHT A 6 MONTH OLD BABY NAME CHLOE MADISON BRITT INTO THE HOSPITAL AND THE BABY WAS NOT BREATHING AND THAT HE HAD BEEN ADVISED THAT THE BABIES CONDITION WAS NOT IMPROVING, OFFICER BALDWIN ADVISED THAT THE MOTHERS BOYFRIEND JEFFREY KEITH HAVARD HAD CAME WITH THEM TO THE HOSPITAL AND WAS IN THE WAITING ROOM WITH HIS OFFICER MARLON SWAZY BECAUSE HE HAD BEEN LEFT ALONE WITH THE CHILD AND WHEN THE MOTHER RETURNED THE BABY WAS BLUE AND NOT BREATHING AND THAT SEXUAL ABUSE WAS HIGHLY SUSPECTED BY THE HOSPITAL STAFF. AT ABOUT 10:45 PM DOCTOR AYESHA DAR CAME FROM THE ER AND ADVISED THAT THE BABY HAD DIED. AT THIS TIME MYSELF, DEPUTY BROWN AND OFFICER BALDWIN WENT TO JEFFREY HAVARD AND ADVISED HIM THAT HE WAS GOING TO THE SHERIFFS OFFICE FOR QUESTIONING AND JEFFREY WAS PLACED INTO DEPUTY BROWNS CAR. I THEN CALLED THE SHERIFFS OFFICE AND HAD THEM PATCH MY PHONE THROUGH TO MAJOR JOHN MANLEY (A-4) AND I ADVISED HIM OF THE SITUATION THAT I WAS AWARE OF AT THAT TIME AND HE ADVISED TO TAKE JEFFREY ON TO THE OFFICE AND HE WOULD BE EN ROUTE TO THE HOSPITAL AND THAT HE WOULD CONTACT SHERIFF TOMMY FERRELL (A-1) AND FOR ME TO MAKE SURE THAT THE CORONER HAD BEEN CONTACTED. I TALKED TO DR. LAURIE PATTERSON THE ER DOCTOR AND SHE ADVISED THAT THE CORONER HAD BEEN CONTACTED. I THEN WENT TO THE MOTHER AND FOUND OUT THAT THIS HAPPENED AT 33 MONTGOMERY RD. UPON MAJOR MANLEY'S ARRIVAL HE ADVISED ME TO CONTACT DEPUTY RONNIE COLEMAN AND HAVE HIM BRING THE CAMERA TO THE HOSPITAL WHICH I DID AND I GOT MY POLAROID FROM MY UNIT AND UPON CORONER JAMES LEE'S ARRIVAL PHOTOS WERE TAKEN OF THE BODY WHERE DR. PATTERSON ADVISED THAT SHE HAD A TORN ANAL AND THE INSIDE OF HER MOUTH WAS TORN WITH BRUISES ON BOTH THIGHS AND ACROSS HER FORE HEAD WHICH WAS NORMAL IN SEXUAL ASSAULT AND THAT SHE HAD FLUID RUNNING FROM THE SIDES OF HER EYES AND SHE HAD SOME TYPE OF HEMORRHAGE IN HER HEAD DUE TO BEING SHAKEN EXTREMELY HARD AT SOME TIME. THE SHERIFF ARRIVED ON THE SCENE AND ADVISED DEPUTY COLEMAN TO TAKE THE MOTHER OF THE BABY TO THE OFFICE SO WE COULD GET A STATEMENT FROM HER AND THEN THE SHERIFF TALKED TO HER MOTHER AND STEPFATHER JOHNNY AND LILLIAN WATSON AND EXPLAINED TO THEM THAT THIS WAS BEING HANDLED AS A CRIMINAL MATTER AT THIS TIME AND THAT A AUTOPSY WOULD BE PERFORMED IN JACKSON, MS.

I LEFT THE HOSPITAL AND WENT BACK TO THE SHERIFF'S OFFICE AND A SHORT TIME LATER I TALKED TO THE SHERIFF AND HE ADVISED ME TO RECOVER ALL CLOTHING FROM JEFFREY HAVARD FOR EVIDENCE WHICH MYSELF DEPUTY BROWN AND DEPUTY COLEMAN DID. UPON MAJOR MANLEY AND THE SHERIFF'S ARRIVAL AT THE SHERIFF'S OFFICE MYSELF AND DEPUTY COLEMAN WERE ADVISED TO TAKE A STATEMENT FROM REBECCA BRITT THE BABIES MOTHER. AFTER REBECCA WAS READ HER MIRANDA RIGHTS WE WERE TALKING TO HER AND THE SHERIFF CAME AND TOOK HER TO HIS OFFICE TO TALK WITH HER IN THE PRESENCE OF THE DISTRICT ATTORNEY RONNIE HARPER AND MAJOR MANLEY. MYSELF AND DEPUTY COLEMAN WERE THEN INSTRUCTED TO GET A STATEMENT FROM REBECCA'S MOTHER AND STEPFATHER WHICH WE DID. MYSELF AND MAJOR MANLEY THEN BROUGHT JEFFREY HAVARD INTO HIS OFFICE FOR QUESTIONING AND HE WAS READ HIS MIRANDA RIGHTS AND WAS ASKED TO SIGN A PERMISSION TO SEARCH HIS HOME FOR EVIDENCE WHICH HE DID SIGN. AFTER QUESTIONING MYSELF AND MAJOR MANLEY THEN WENT TO 33 MONTGOMERY RD. TO SEARCH THE TRAILER AND TAKE PHOTOS OF THE SCENE WITH DEPUTY BROWN AND DEPUTY COLEMAN ARRIVING A SHORT TIME LATER. THE EVIDENCE RECOVERED WAS PLACED IN PAPER SACKS AND LABELED AND BROUGHT TO THE SHERIFF' OFFICE AND SECURED SO THEY COULD BE TAKEN TO THE CRIME LAB IN JACKSON THAT DAY.
