THIS WAS IN REFERENCE TO A ORDER SIGNED BY CIRCUIT JUDGE FORREST A. JOHNSON ORDERING THESE SAMPLES BE TAKEN.

AT APPROX. 3:22 PM JEFFREY WAS RESTRAINED AND TRANSPORTED TO NATCHEZ REGIONAL HOSPITAL BY DEPUTY PACE AND MYSELF.

UPON ARRIVAL AT THE HOSPITAL APPROX. 3:29 PM MADE CONTACT WITH THE DOCTOR A DR. ANDREW BERENS AND ALSO A NURSE BRYAN RABB.

I EXPLAINED WHAT WAS REQUESTED AND DR. BERENS TALKED TO SHERIFF TOMMY FERRELL ON THE PHONE AND IT WAS DECIDED TO DO A COMPLETE SEXUAL ASSAULT KIT ON THE SUBJECT JEFFREY KEITH HAVARD.

THE SAMPLES WERE RECOVERED BY DR. BERENS AND NURSE RABB AND WITNESSED BY MYSELF AND DEPUTY JAMES PACE. THE EVIDENCE WAS PLACED INTO THE PACKAGE GIVEN AND SEALED, WITH THE RED EVIDENCE STICKER GIVEN, I ALSO ADVISED NURSE RABB TO ALSO PLACE A PIECES OF TAPE ON THE PACKAGE ON EACH SIDE OF THE OPENING AND INITIAL THIS.
